

Registration Instructions for the CDC Worksite Health ScoreCard

1. Register by visiting the **CDC Worksite Health ScoreCard**. Click on “Get started” to create an employer administrator account, then follow the steps as shown on the screenshots below.

Create a CDC Worksite Health ScoreCard account to assess and build health promotion programs offered to employees, save your information electronically, access reports, and monitor progress over time.

To participate in the CDC Worksite Health ScoreCard, each employer must register two types of accounts:

- **One employer administrator account** for users who maintain employer-level information or who review or complete scorecards for multiple worksite accounts
- **One or more worksite accounts** (one for each worksite) for users who maintain worksite-level information and complete scorecards for individual worksites

Note: An employer administrator account must be created before you can register a worksite and complete a CDC Worksite Health ScoreCard.
