If you have other family members on the <b>plan</b> , each family member must meet their own individual <b>deductible</b> until the total amount of deductible expenses paid by all family members meets the overall family <b>deductible</b> .
Are there services covered before you meet your <u>deductible</u> ?	No.	You will have to meet the <b>deductible</b> before the <b>plan</b> pays for any services.
