What is the overall <u>deductible</u> ?	\$0	Generally, you must pay all the costs from <b>providers</b> up to the <b>deductible</b> amo before this <b>plan</b> begins to pay. If you have other family members on the <b>plan</b> , e family member must meet their own individual <b>deductible</b> until the total amount deductible expenses paid by all family members meets the overall family <b>deductible</b> .		
Are there services covered before you meet your <u>deductible</u> ?	No.	You will have to meet the <b>deductible</b> before the <b>plan</b> pays for any services.		
Are there other <u>deductibles</u> for specific services?	Yes. <b>\$3,500</b> person/ <b>\$7,000</b> family for prescription drugs. There are no other specific <b>Deductibles</b> . #### Does this plan provide Minimum Essential Coverage? Yes
