Important Questions	Answers	Why this Matters:
<b>What is the overall <u>deductible</u>?</b>	<b>\$3,000</b> person/ <b>\$6,000</b> family in-network per calendar year.	Generally, you must pay all the costs from <b>providers</b> up to the <b>deductible</b> amount before this <b>plan</b> begins to pay. If you have other family members on the <b>plan</b> , each family member must meet their own individual <b>deductible</b> until the total amount of deductible expenses paid by all family members meets the overall family <b>deductible</b> .
<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. Prescription drugs, <b>Preventive</b> Services, and office visits are covered before you meet your <b>Deductible</b> .	This <b>plan</b> covers some items and services even if you haven't yet met the <b>deductible</b> amount. But a <b>copayment</b> or <b>coinsurance</b> may apply. For example, this <b>plan</b> covers certain <b>preventive services</b> without <b>cost sharing</b> and before you meet your <b>deductible</b> . <b>Are there other <u>deductibles</u> for specific services?</b>	Yes. <b>\$750</b> person/ <b>\$2,250</b> family for prescription drugs. There are no other specific <b>Deductibles</b> . <b>What is the <u>out-of-pocket limit</u> for this <u>plan</u>?</b>	<b>\$8,750</b> person/ <b>\$17,500</b> family in-network per calendar year.	The <b>out-of-pocket limit</b> is the most you could pay in a year for covered services. <b>What is not included in the <u>out-of-pocket limit</u>?</b>	<b>Premiums</b> , <b>balance-billed</b> charges, <b>preventive services</b> , healthcare this <b>plan</b> doesn't cover, and penalties for failure to obtain <b>preauthorization</b> for services.	Even though you pay these expenses, they don't count toward the <b>out-of-pocket limit</b> .
<b>Will you pay less if you use a <u>network provider</u>?</b>	Yes. ### Does this plan provide Minimum Essential Coverage? Yes

**Minimum Essential Coverage** generally includes **plans**, **health insurance** available through the **Marketplace** or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of **Minimum Essential Coverage**, you may not be eligible for the **premium tax credit**.
