<b>What is the overall <u>deductible</u>?</b>	<b>\$5,900</b> person/ <b>\$11,800</b> family in-network per calendar year.	Generally, you must pay all the costs from <b><u>providers</u></b> up to the <b><u>deductible</u></b> amount before this <b><u>plan</u></b> begins to pay. If you have other family members on the <b><u>plan</u></b> , each family member must meet their own individual <b><u>deductible</u></b> until the total amount of deductible expenses paid by all family members meets the overall family <b><u>deductible</u></b> .
<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. Prescription drugs, <b><u>Preventive</u></b> Services, and office visits are covered before you meet your <b><u>Deductible</u></b> .	This <b><u>plan</u></b> covers some items and services even if you haven't yet met the <b><u>deductible</u></b> amount. But a <b><u>copayment</u></b> or <b><u>coinsurance</u></b> may apply. For example, this <b><u>plan</u></b> covers certain <b><u>preventive services</u></b> without <b><u>cost sharing</u></b> and before you meet your <b><u>deductible</u></b> . <b>Are there other <u>deductibles</u> for specific services?</b>	Yes. <b>\$750</b> person/ <b>\$2,250</b> family for prescription drugs. There are no other specific <b><u>Deductibles</u></b> . <b>What is the <u>out-of-pocket limit</u> for this <u>plan</u>?</b>	<b>\$8,500</b> person/ <b>\$17,000</b> family in-network per calendar year.	The <b><u>out-of-pocket limit</u></b> is the most you could pay in a year for covered services. <b>Will you pay less if you use a <u>network provider</u>?</b>	Yes. ### Does this plan provide Minimum Essential Coverage? Yes

If you are eligible for certain types of **Minimum Essential Coverage**, you may not be eligible for the **premium tax credit**.
