What is the overall <u>deductible</u> ?	<b>\$5,000</b> person/ <b>\$10,000</b> family in-network and <b>\$20,300</b> person/ <b>\$40,600</b> family out-of-network per calendar Year.	Generally, you must pay all the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of deductible expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Prescription drugs, <u>Preventive</u> Services, and office visits are covered before you meet your <u>Deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost sharing</u> and before you meet your <u>deductible</u> . Will you pay less if you use a <u>network provider</u> ?	Yes. Do you need a referral to see a <u>specialist</u> ?	No.	You can see the specialist you choose without a referral.

### Does this plan provide Minimum Essential Coverage? Yes

If you are eligible for certain types of **Minimum Essential Coverage**, you may not be eligible for the **premium tax credit**.
