What is the overall <u>deductible</u> ?	\$7,000 person/ \$14,000 family in-network and \$20,300 person/ \$40,600 family out-of-network per calendar Year.	Generally, you must pay all the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Prescription drugs, Preventive Services, and office visits are covered before you meet your Deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . Are there other <u>deductibles</u> for specific services?	Yes. \$2,500 per person for prescription drugs. There are no other specific Deductibles .	You must pay all of the costs for these services up to the specific deductible amount before this plan begins to pay for these services.
What is the <u>out-of-pocket limit</u> for this <u>plan</u> ?	\$9,900 person/ \$19,800 family in-network, \$91,000 person/ \$182,000 family out-of-network per calendar year.	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the <u>out-of-pocket limit</u> ?	Premiums , balance-billed charges, preventive services , healthcare this plan doesn't cover, and penalties for failure to obtain preauthorization for services.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
Will you pay less if you use a <u>network provider</u> ?	Yes. To find an in-network provider visit selecthealth.org/find-care or call Member Services at 800-538-5038.	This plan uses a provider network . You will pay less if you use a provider in the plan's network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Be aware your network provider might use an out-of-network provider for some services (such as lab work). Check with your provider before you get services.
Do you need a referral to see a <u>specialist</u> ?	No.	You can see the specialist you choose without a referral.

Does this plan provide Minimum Essential Coverage? Yes

Minimum Essential Coverage generally includes **plans**, **health insurance** available through the **Marketplace** or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of **Minimum Essential Coverage**, you may not be eligible for the **premium tax credit**.

Does this plan meet the Minimum Value Standards? Yes

If your **plan** doesn't meet the **Minimum Value Standards**, you may be eligible for a **premium tax credit** to help you pay for a **plan** through the **Marketplace**.

About these Coverage Examples:



This is not a cost estimator. Treatments shown are just examples of how this **plan** might cover medical care. Your actual costs will be different depending on the actual care you receive, the prices your **providers** charge, and many other factors. Focus on the **cost sharing** amounts (**deductibles**, **copayments** and **coinsurance**) and **excluded services** under the **plan**. Use this information to compare the portion of costs you might pay under different health **plans**. Please note these coverage examples are based on self-only coverage.

Peg is Having a Baby

(9 months of in-network pre-natal care and a hospital delivery)

- Specialist** office visits (*prenatal care*)
- Childbirth/Delivery Professional Services

- Diagnostic tests** (*ultrasounds and blood work*)
- Specialist** visit (*anesthesia*)

- Primary care physician** office visits (*including disease education*)
- Diagnostic tests** (*blood work*)
- Prescription drugs**
- Durable medical equipment** (*glucose meter*)

Mia's Simple Fracture

(in-network emergency room visit and follow up care)

- Emergency room care** (*including medical supplies*)
- Diagnostic test** (*x-ray*)
- Durable medical equipment** (*crutches*)
- Rehabilitation services** (*physical therapy*)
