What is the overall <u>deductible</u> ?	<b>\$4,000</b> person/ <b>\$8,000</b> family in-network and <b>\$20,300</b> person/ <b>\$40,600</b> family out-of-network per calendar Year.	Generally, you must pay all the costs from <b>providers</b> up to the <b>deductible</b> amount before this <b>plan</b> begins to pay. If you have other family members on the <b>plan</b> , each family member must meet their own individual <b>deductible</b> until the total amount of deductible expenses paid by all family members meets the overall family <b>deductible</b> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Prescription drugs, <b>Preventive</b> Services, and office visits are covered before you meet your <b>Deductible</b> .	This <b>plan</b> covers some items and services even if you haven't yet met the <b>deductible</b> amount. But a <b>copayment</b> or <b>coinsurance</b> may apply. For example, this <b>plan</b> covers certain <b>preventive services</b> without <b>cost sharing</b> and before you meet your <b>deductible</b> . ### Does this plan provide Minimum Essential Coverage? Yes

If you are eligible for certain types of **Minimum Essential Coverage**, you may not be eligible for the **premium tax credit**.
