What is the overall deductible?	<b>\$6,500</b> person/ <b>\$13,000</b> family in-network per calendar year.	Generally, you must pay all the costs from <b>providers</b> up to the <b>deductible</b> amount before this <b>plan</b> begins to pay. If you have other family members on the <b>plan</b> , each family member must meet their own individual <b>deductible</b> until the total amount of deductible expenses paid by all family members meets the overall family <b>deductible</b> .
Are there services covered before you meet your deductible?	Yes. Certain prescription drugs, <u>Preventive</u> Services, and office visits are covered before you meet your <u>Deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. ## **Excluded Services & Other Covered Services:**

- Abortions/termination of pregnancy except in limited circumstances
- Acupuncture
- Administrative services/charges
- Adult **preventive** eye exams
- Cosmetic, reconstructive or corrective services, except in limited circumstances
- Dental care (adult/child), except in limited circumstances
- Dental check-up
- Experimental and/or investigational services

- Immunizations for Anthrax, BCG, Cholera, Plague, Typhoid and Yellow Fever
- Long-term care
- Non-Emergency care when traveling outside the U.S.
- Orthotic and other corrective appliances for the foot
- Routine foot care
- Services for which a third-party is or may be responsible
- Services related to certain illegal activities
- Services that are not medically necessary

# Does this plan provide Minimum Essential Coverage? Yes
